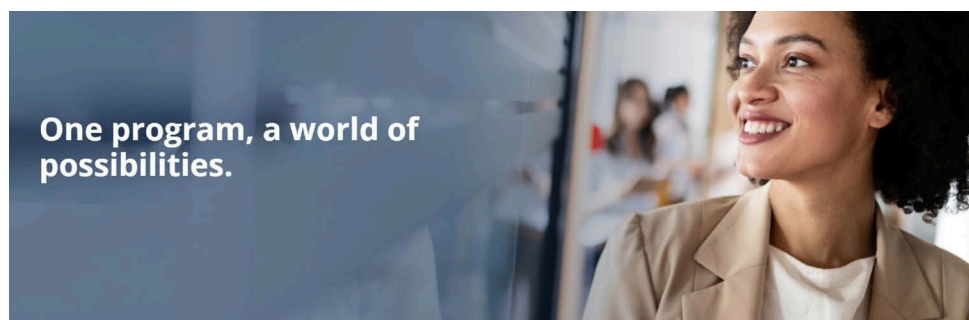

Program DETAILS

Who is it for?

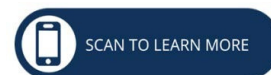
The Graduate Diploma merges theory and practice to prepare students for a number of vital roles in the immigration sector, as well as functions that support organizations on immigration and citizenship matters. These include:

- Prospective Regulated Canadian Immigration Consultants (RCICs)
- Paralegals
- Advisors and recruitment specialists at universities and colleges
- Human resources professionals
- Leaders in immigrant settlement organizations
- Constituency assistants for members of federal, provincial, and territorial legislatures
- Immigration and border policy analysts and program specialists in government agencies
- Business development leads at law firms

Program STRUCTURE

The GDipICL program offers two study plans for September and January admission cycles: full-time and part-time. Full-time students will complete 9 courses over 3 consecutive terms in under 12 months, while part-time students will complete 9 courses over 6 consecutive terms in 24 months.

Applicants select their study plan via the application. Study plans are preset for all students and students are enrolled in courses automatically.

Completion Requirements

Students must complete all nine courses with a minimum grade of B- to graduate.

Cost & Financing

Tuition

STUDY, interact and collaborate.

Admission REQUIREMENTS

- Bachelor's degree with a minimum of a B average or equivalent.
- Two references, including one academic reference if you have attended a post-secondary program within 2 years of applying.
- If English is not a native language, prospective students must meet the English language proficiency requirements in writing, speaking, reading, and listening.
- A 400-word personal statement of interest outlining your motivation to apply for the program and how your previous training and/or experiences makes you the right candidate for the program.

Before you APPLY

2. Gather all required documents:
 - Transcript(s) for all post-secondary education either completed or in-progress.
 - Valid language scores, if required (see our [Admissions page](#) for details).Contact information for two referees.
A personal statement of interest (maximum: 400 words) written by the applicant explaining your motivation to apply for the program and how your previous training and/or experiences make you the right candidates for the program.
